

**ORDINANCE 41**

**AN ORDINANCE OF THE MCKINLEYVILLE COMMUNITY SERVICES DISTRICT  
AMENDING THE DISTRICT'S RULES AND REGULATIONS TO AMEND  
PROVISIONS RELATED TO RECREATION**

THE BOARD OF DIRECTORS OF THE MCKINLEYVILLE COMMUNITY  
SERVICES DISTRICT DOES HEREBY ORDAIN AS FOLLOWS:

Section 1. Rule 40.01 is amended in whole to read:

"Rule 40.01. MEMBERSHIP. The McKinleyville Community Services District Recreation Advisory Committee shall consist of nine (9) members who shall serve without compensation selected as follows:

- a. Two (2) members shall be members of the District Board.
- b. Two (2) members shall be members of the McKinleyville Area Fund Board of Directors. The McKinleyville Area Fund Board of Directors may recommend members for consideration and approval by the District Board.
- c. Five (5) members shall be resident electors of the District representing to the extent possible various recreational interests of the community including but not limited to seniors, youth, sports, business, equestrian, environment and trails.

Recommendations for appointment may be made by the then current members of the advisory committee."

Section 2. Rule 40.04 is amended in whole to read:

"Rule 40.04. TERMS OF OFFICE. Appointment of District Board Members shall be for a term of two (2) years with no individual serving for more than one term in succession. Appointment of Fund members and community members shall be for a term of four years with no individual serving for more than one term in succession. Terms shall be staggered so that the terms of no more than three (3) committee members expire during a given year. The annual expiration date of appointment shall be December 31st."

Section 3. The following subsections are added to Rule 41.01.

"(J) Discharge any firearm or bow & arrows within the park boundaries for any reason.

(K) Make campfires or fires for any reason in any area that is not properly equipped to contain a fire."

Section 4. The following subsections are added to Rule 41.04.

"(D) The District may withdraw the privilege to use alcoholic beverages at anytime if the rules and regulations are not abided by.

(E) Use of intoxicating beverages other than liquor and any other illicit chemical or drug is prohibited."


Section 5. This ordinance when effective shall be added to the Rules and Regulations of the District as a codified ordinance of the Board of Directors of the McKinleyville Community Services District.


